### **Emergency Overview**

Physical Description & Colour: Mildly coarse powder, grey and multicoloured specks.

Odour: Mild odour.

**Major Health Hazards:** This is an antibiotic preparation. Any person with a history of allergies to this class of substances should avoid all contact with this product as it may cause sensitisation. Eye irritant.

### Section 4 - First Aid Measures

#### General Information:
